## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Olympic Medical Center from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Cash receipting
- Accounts receivable – patient billings and adjustments
- Tracking and monitoring of theft sensitive assets including pharmaceutical inventory
- Use and tracking of restricted funds – donations

## INFORMATION ABOUT THE DISTRICT

Public Hospital District No. 2 of Clallam County, doing business as Olympic Medical Center, provides health care services to Port Angeles, Sequim and surrounding communities. The District operates Olympic Memorial Hospital, a 126 bed licensed general acute-care facility, and home health services through Olympic Medical Home Health. The District also operates Olympic Medical Imaging Center, Olympic Medical Cancer Center, Olympic Medical Physical Therapy and Rehabilitation, Olympic Medical Laboratory, Olympic Medical Surgical Services, Olympic Medical Cardiac Services and Olympic Medical Physicians, which includes eight physician clinics.

An elected, seven-member Board of Commissioners governs the District. The Board appoints an Administrator to oversee the District's daily operations as well as its 1,421 employees. For 2017, the District operated on an annual budget of approximately \$182.2 million.
